



THE GREAT FLORIDA OUTDOORS RAFFLE Rules and Regulations

The Great Florida Outdoors Raffle ("Raffle") is a drawing of chance for prizes and is being operated and hosted by Fish & Wildlife Foundation of Florida, Inc., a Florida not-for-profit corporation having its principal place of business at 620 S Meridian St Tallahassee, FL 32399 ("Foundation"). The following terms are the official rules and regulations governing the conduct and operation of the Raffle ("Official Rules and Regulations"):

1. OBTAINING RAFFLE TICKETS. Tickets for the Raffle (each being a "Raffle Ticket," multiple being "Raffle Tickets") may be obtained from the Foundation. Entrants may obtain Raffle Tickets online, by making a suggested minimum donation of \$20 per Raffle Ticket, or \$50 for three Raffle Tickets, or \$100 for ten Raffle Tickets. The Foundation's official Raffle website is wildlifeflorida.org/raffle. Alternatively, Entrants may request a Raffle Ticket via mail, addressed to "Fish & Wildlife Foundation of Florida, Inc., P.O. Box 11010 Tallahassee, FL 32302, ATTN: RAFFLE." Raffle Ticket requests submitted via mail shall be made by mailing to the Foundation a typewritten or computer-generated document listing the entrant's full legal name, area code and phone number, valid e-mail address, and should be accompanied by any donation the person chooses to make for the Raffle Ticket. One Raffle Ticket per written mailed request, up to a maximum of 100 Raffle Tickets, unless the Entrant wishes to acquire Raffle Tickets in bulk using the suggested minimum donation values stated above. For all Raffle Ticket requests, including those submitted by mail, an acknowledgment will be electronically mailed to the e-mail address provided by the entrant. The Foundation will not mail paper Raffle Tickets; a valid e-mail address is required for all entrants. The entrant is responsible for monitoring all spam and junk e-mail folders for the Raffle Tickets. All checks and money orders must be made payable to "Fish & Wildlife Foundation of Florida, Inc." Entrants should not send cash to the Foundation for Raffle Ticket donations. *No purchase, donation, or contribution is necessary to enter the Raffle.

2. LIMITATIONS AND RESTRICTIONS. Each Raffle Ticket may be obtained by one entrant only, in that entrant's own name. At the time of entry, each entrant will be required to provide sufficient identifying information to ensure compliance with these Official Rules and Regulations. A maximum of 100 Raffle Tickets may be obtained by each entrant for the duration of the Raffle. Any Prize (defined below) and related tax liability will belong to the entrant named on the Raffle Ticket. All ticket transactions are final. No entrant names can be altered, changed, or substituted after submission or entry. No refunds are available or will be made. Prizes and Raffle Tickets have no cash surrender value, although certain Prizes may be substituted for a cash prize, as specified below in these Official Rules and Regulations. The Foundation assumes no responsibility for lost, late, misdirected or non-delivered mail, e-mail or fax messages, or any other failure to receive a request or deliver Raffle Tickets or receipts prior to the Request Deadline (defined below). No reproduction of a Raffle Ticket is permitted. Any Raffle Ticket or entry that is deemed, in the sole discretion of the Foundation, to be defective, illegible, counterfeited, incomplete, or in violation of these Official Rules and Regulations will not be honored. Donations received with defective, illegible, counterfeited, or incomplete entries, or entries violating these Official Rules and Regulations, will not be refunded to the entrant, and will be treated as general donations to the Foundation.

3. REQUEST DEADLINE. Requests for Raffle Tickets must be tendered so that they are received by the Foundation no later than ninety-six (96) hours prior to the Drawing (defined below) date ("Request Deadline"). Any requests received after the Request Deadline will not be honored.

4. ELIGIBILITY. Each entrant must be at least eighteen (18) years of age at the time of obtaining the Raffle Ticket, and must be a U.S. Citizen (further subject to all Prize restrictions, outlined below). Raffle Tickets may not be obtained in the name of a business, trust, corporation or other entity, or wherever prohibited by applicable law. Raffle Tickets may not be purchased by Foundation board members or employees of the Florida Fish and Wildlife Conservation Commission ("FWC"), to include each of their immediate family members (i.e. parent, spouse, child, or sibling). Entrants do not need to be present at the Drawing in order to win. All federal, state and local laws and regulations apply. Entrants must lawfully be able to receive, possess and utilize the Prizes. See FWC licensure rules at www.myfwc.com/license. Questions regarding the Raffle should be directed to the Foundation, using the below contact information.

5. DRAWING. The drawing for the winning Raffle Tickets will be held on December 30, 2022, at approximately 12:00 p.m., at 620 S. Meridian Street, Tallahassee, FL ("Drawing"). The winners will be determined by chance at the Drawing. Raffle Tickets are required to participate in the Drawing. The Drawing date and all other dates stated in these Official Rules and Regulations may be adjusted in the absolute discretion of the Foundation. The Foundation does not reserve any discretion to cancel the Raffle. No in-person attendance by entrants or the public will be permitted at the Drawing.

6. NOTIFICATION OF WINNER AND SELECTION OF PRIZE. The Foundation will notify all eligible winners of the Raffle within twenty-four (24) hours of the Drawing. Notifications to winners will be delivered via e-mail only, using the e-mail address set forth on the Raffle Ticket entry. The prizes identified below (collectively the "Prizes"; each a "Prize") will be awarded on a first drawn, first choice basis. All Prize selections are final, and the winning entrants will not be permitted to exchange or substitute the Prize selected. Specifically, the first eligible entrant drawn will be entitled to select one (1) of the individual Prizes. Thereafter, the second eligible entrant drawn will be entitled to select one of the remaining Prizes, and so on, until each Prize has been distributed to an eligible entrant. Following initial notification of all winners, the Foundation will begin the Prize selection process by e-mailing the first winner drawn, who will have two (2) weeks from such e-mailed notice to select and take possession of a Prize. Prize selection must occur via reply e-mail to the Foundation's e-mail notification. If the winning Raffle Ticket holder does not reply to the Foundation's e-mail notification, and take possession of the Prize, within this two (2) week period, such Raffle Ticket holder will be disqualified from the Raffle, including from Prize selections related to all other winning Raffle Tickets. If a winner does not comply with these Official Rules and Regulations, the winner will be disqualified from the Raffle. Upon the earlier of (a) the disqualification of the first drawn winner; (b) Prize selection and pickup/possession by the first drawn winner; or (c) rejection by the first drawn winner, the Foundation will then e-mail the second drawn winner, who will have two (2) weeks from such e-mailed notice to select and take possession of a Prize. This process will continue until all Prizes have been selected and picked up/possessed by eligible winners. For the fishing boat Prize only, the two-week period referenced above for pick-up of the Prize shall be a thirty (30) day period, commencing on the Foundation's e-mail notice to the winner of the Prize being ready for pick-up, which is subject to manufacturer production schedule. The winners of the Raffle will be instructed via e-mail as to how to take possession of or acquire their Prize at the time of notification by the Foundation. Winners may, in the sole discretion of the Foundation, be required to travel to a pickup location in the State of Florida, at the winner's sole expense, and take a photograph with their Prize. Winners will be solely responsible for all delivery, pickup, shipping, or transportation costs. Any questions should be relayed to the Foundation at the contact information below. The winners of the Raffle may be required to sign an affidavit of eligibility. All winners must complete an IRS Form W-9 prior to taking possession of or acquiring a Prize. The Foundation will issue a 1099-Misc for Prizes equal to the fair market value of the Prize on the date the winner was



selected (or cash value where cash is selected as a Prize, as specified below), to the extent required by applicable law. Each winner is responsible for any payment of all local, state and federal taxes resulting from the income or use attributable to the receipt of any Prize, and should consult his or her professional tax advisors regarding the Prize awarded. The Foundation will not provide tax advice to any winner of the Raffle.

7. PRIZES. The Prizes are as follows:

I. One (1) Contender 22 Sport Fishing Boat with Trailer and Motor. This Prize will include one (1) new Contender 22 sport fishing boat, one (1) new boat trailer, and one (1) new Yamaha 250 HP outboard motor. All equipment, including the motor, batteries, and trailer, will be unused, and all applicable preparation and maintenance of the same for use by the winner will be the responsibility of the winner. Winner will be solely responsible for picking up and transporting this Prize, which shall be operated subject to, and in accordance with, all restrictions set forth by Florida law. The Prize may differ in appearance and functionality from the photographs associated with the Raffle. The winner of this prize will be required to submit all documentation and information requested by the Foundation, Contender, and the Florida Department of Highway Safety and Motor Vehicles (and any similar government entity in the location where this Prize is intended to be stored, titled, registered, or transported). Title to the Prize will not transfer until all applicable documentation has been completed and approved, and the winner will be required to provide evidence of the appropriate registration documentation before picking up the Prize. The winner is responsible for any and all sales and use taxes imposed by the Florida Department of Revenue. Risk of loss will pass upon winner claiming this Prize. The winner must be eligible to obtain, and must obtain, a boating safety card, as applicable, and have a valid driver's license. The Foundation makes no representation or guaranty concerning the condition of the Prize, and the Prize is taken "AS IS," with all faults. The Foundation does not in any way, expressly or impliedly, give any warranties to the winner, and the Foundation is not responsible for any defective or malfunctioning equipment. In addition to all other disclaimers contained in these Official Rules and Regulations, the Foundation EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THIS PRIZE. Any and all warranties are strictly a matter between the manufacturer and the winner, and only the extent the manufacturer offers such warranty. The winner of this Prize may be required to sign an affidavit of eligibility. This Prize expressly does not include any storage, docking or slip fees, maintenance, fishing gear, bait, fuel, towing, or guidance. This Prize is not transferrable. In the event the winner of this Prize elects to not take possession of this Prize, the winner may instead select a one-time alternative cash prize in the total amount of Fifty-Thousand U.S. Dollars (\$50,000.00) from the Foundation. The winner must notify the Foundation via e-mail of the winner's alternative cash prize selection within the two-week notification period stated above. Upon such alternative cash prize selection and receipt of the winner's IRS Form W-9, the Foundation will issue one check payable to the winner in the total amount of \$50,000.00. Should the winner elect the cash prize alternative, the primary Prize for this category will not be available to any other Raffle winner.

IV. One (1) Backwoods Python Hunt. This Prize will include one (1) Burmese python hunting tour in the Florida Everglades for up to four (4) individuals. All attendees must be at least sixteen (16) years old. The winner must be one of the attendees. The attendees will be accompanied by Florida Fish & Wildlife Conservation Commission (FWC) staff. Attendees are required to follow the legal method of take at the time of the hunt. The winner will not be paid or compensated in any way for any activities engaged in during this experience. The experience must be booked and occur within the 2023 calendar year, or the Prize will expire. The scheduling of the experience will depend on the availability of FWC staff and the weather. There is no raincheck for this experience. The winner will be required to wear attire appropriate for the trip, and FWC staff may refuse to permit the attendees from attending the tour if the individual is not deemed reasonably prepared or capable of participating in the tour. This Prize expressly does not include any attire, gear, transportation or weapons. This experience is subject to all restrictions set forth by FWC and Florida law. The winner may be required to sign a waiver and/or release of liability prior to the experience. This Prize is not transferrable.

Fair Market Value: \$800

V. One (1) Airboat Alligator Survey. This Prize will include one (1) opportunity to participate in a nightlight survey of alligators with an FWC biologist for up to two (2) individuals on Lake Okeechobee, Florida; based on airboat availability this opportunity may be limited to one participant. The winner will not be paid or compensated in any way for any activities engaged in during this experience. The experience must be booked and occur within the 2023 calendar year, or the Prize will expire. The scheduling of the experience will depend on the availability of the FWC and the weather. There is no raincheck for this experience. The conditions, experience, and overall schedule for the trip may vary. All surveys take place at night, on the water, and you will get wet. The winner will be required to wear attire appropriate for the trip, briefed on and follow FWC safety procedures, and the FWC may refuse to permit the winner from attending a



trip if the individual is not deemed reasonably prepared or capable of participating in the trip. This Prize expressly does not include any attire, gear, or transportation. This experience is subject to all restrictions set forth by the FWC and Florida law. The winner may be required to sign a waiver and/or release of liability prior to the experience. This Prize is not transferrable. All participants must be at least 16 years old.

VI. One (1) Clay Shooting Instruction Course. This Prize will include one (1) clay shooting instructional session at the new Palm Beach Shooting Sports Complex for up to four (4) individuals. The winner must be one of the attendees. The attendees will be provided with a rental shotgun (make, model, and type are subject to availability), eye protection, ear protection, and golf carts at no cost to the attendees. All gear other than disposable foam ear protection must be returned at the end of the training session. The attendees will also each be provided with up to one-hundred (100) clay targets and ammunition. Clay targets have no redeemable cash value, and all unused clays will be forfeited. The attendees will receive guidance from an instructor certified by the National Sporting Clays Association. The Foundation does not in any way, expressly or impliedly, give any warranties to the winner related to equipment provided by the Palm Beach Shooting Sports Complex, and the Foundation is not responsible for any defective or malfunctioning equipment. Each participant is solely responsible for the safe operation of firearms used during the instructional session. In addition to all other disclaimers contained in these Official Rules and Regulations, the Foundation EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THE EQUIPMENT PROVIDED BY THE PALM BEACH SHOOTING SPORTS COMPLEX. The experience must be booked and occur within the 2023 calendar year, or the Prize will expire. The scheduling of the experience will depend on the availability of the FWC, the instructor, the Palm Beach Shooting Sports Complex, and the weather. There is no raincheck for this experience. This experience is subject to all restrictions set forth by the FWC, the instructor, the Palm Beach Shooting Sports Complex, and Florida law. The winner may be required to sign a waiver and/or release of liability prior to the experience. This Prize is not transferrable.

VII. One (1) Fisheries Biologist for a Day. This Prize will include one (1) day of shadowing a Fisheries Biologist from the FWC for one (1) individual. The winner will have the opportunity to select one of four different trips on which they can attend. The winner will not be paid or compensated in any way for any activities engaged in during this experience. The experience must be booked and occur within the 2023 calendar year, or the Prize will expire. The scheduling of the experience will depend on the availability of the FWC, the weather, and the specific trip chosen. There is no raincheck for this experience. The conditions, experience, and overall schedule for the trip may vary. The winner will be required to wear attire appropriate for the trip, and the FWC may refuse to permit the winner from attending a trip if the individual is not deemed reasonably prepared or capable of participating in the trip. This Prize expressly does not include any attire, gear, or transportation. This experience is subject to all restrictions set forth by the FWC and Florida law. The winner may be required to sign a waiver and/or release of liability prior to the experience. This Prize is not transferrable. All participants must be at least 16 years old.

VIII. Five (5) Lifetime Gold Sportsman's License. This Prize will include one (1) hard, printed license card for an adult Florida resident to engage in lawful sporting activities such as hunting, saltwater fishing, freshwater fishing and other activities, as identified by the FWC. Issuance of this license is subject to all restrictions set forth by the FWC and Florida law, as such restrictions currently exist or may be amended from time to time. The winner of this prize will be required to submit all documentation and information requested by the FWC and any other applicable government agency to process the winner's license application. The Foundation makes no representation or guaranty concerning the processing times or costs, or the acceptance or approval of the winner's application by the FWC. The FWC's eligibility determination will be final, and the Foundation's identification of the winner of this Prize shall not be construed to be the FWC's approval of the license application. This Prize expressly does not include any fishing gear, bait, transportation, or guidance. The Foundation is not responsible for any lost, stolen, broken, or misplaced license cards. This Prize may be transferred to another individual meeting all eligibility requirements outlined in these Official Rules and Regulations, one time, within thirty (30) days after being notified that the entrant has won the Prize. The transfer may only be made without any consideration exchanged, monetary or otherwise. The transferee of such Prize shall ensure compliance with all applicable law and shall provide to the Foundation identification deemed sufficient in the sole discretion of the Foundation. Transferring of the Prize does not entitle the entrant to an additional Prize if another Raffle Ticket belonging to that entrant is drawn. In the event the winner of this Prize is not a Florida resident, the winner may instead select a one-time alternative cash prize in the total amount of One Thousand U.S. Dollars (\$1,000.00) from the Foundation. The winner must notify the Foundation via e-mail of the winner's alternative cash prize selection within the two-week notification period stated above. Upon such alternative cash prize selection and receipt of the winner's IRS Form W-9, the Foundation will issue one check payable to the winner in the total amount of \$1,000.00. Should the winner elect the cash prize alternative, the primary Prize for this category will not be available to any other Raffle winner.

IX. Ten (10) Five-Year Gold Sportsman's License. This Prize will include one (1) hard, printed license card for an adult Florida resident to engage in lawful sporting activities such as hunting, saltwater fishing, freshwater fishing and other activities, as identified by the FWC, for the calendar years of 2023 through and including 2027. Issuance of this license is subject to all restrictions set forth by the FWC and Florida law, as such restrictions currently exist or may be amended from time to time. The winner of this prize will be required to submit all documentation and information requested by the FWC and any other applicable government agency to process the winner's license application. The Foundation makes no representation or guaranty concerning the processing times or costs, or the acceptance or approval of the winner's application by the FWC. The FWC's eligibility determination will be final, and the Foundation's



identification of the winner of this Prize shall not be construed to be the FWC's approval of the license application. This Prize expressly does not include any fishing gear, bait, transportation, or guidance. The Foundation is not responsible for any lost, stolen, broken, or misplaced license cards. This Prize may be transferred to another individual meeting all eligibility requirements outlined in these Official Rules and Regulations, one time, within thirty (30) days after being notified that the entrant has won the Prize. The transfer may only be made without any consideration exchanged, monetary or otherwise. The transferee of such Prize shall ensure compliance with all applicable law and shall provide to the Foundation identification deemed sufficient in the sole discretion of the Foundation. Transferring of the Prize does not entitle the entrant to an additional Prize if another Raffle Ticket belonging to that entrant is drawn. In the event the winner of this Prize is not a Florida resident, the winner may instead select a one-time alternative cash prize in the total amount of Four Hundred Ninety-Four U.S. Dollars (\$499.00) from the Foundation. The winner must notify the Foundation via e-mail of the winner's alternative cash prize selection within the two-week notification period stated above. Upon such alternative cash prize selection and receipt of the winner's IRS Form W-9, the Foundation will issue one check payable to the winner in the total amount of \$499.00. Should the winner elect the cash prize alternative, the primary Prize for this category will not be available to any other Raffle winner.

The Foundation makes no representation or guaranty concerning the condition of this Prize, and this Prize is taken "AS IS," with all faults. The Foundation does not in any way, expressly or impliedly, give any warranties to the winner, and the Foundation is not responsible for any defective or malfunctioning equipment. In addition to all other disclaimers contained in these Official Rules and Regulations, the Foundation EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE WITH REGARD TO THIS PRIZE. This Prize expressly does not include any fishing lures, bait, or guidance. This Prize is not transferrable.

Prizes may be subject to additional terms and restrictions as set forth by the supplier of such Prize, including, but not limited to, rules and restrictions set forth by the Foundation or other sponsoring entities.

8. PRIVACY. By submitting or providing any telephone number (including a mobile telephone number), e-mail address, or other contact information in this Raffle, you expressly give consent to be contacted by the Foundation using all such contact information. By entering the Raffle, entrants agree that their names, likenesses and/or information provided in connection with the Raffle entry may be used for the benefit of the Foundation and the FWC, including, but not limited to, being disclosed to and used by the Foundation for publicity purposes in newspapers or other media, including print venues, television, radio, social media, or online (including the website of the Foundation or the FWC). All other personal information collected in connection with the Raffle, as well as all visits to the Foundation's website, will be subject to the Foundation's privacy policy (<https://wildlifeflorida.org/privacy-policy/>) and terms and conditions (<https://wildlifeflorida.org/terms-conditions/>). Except as specifically provided herein, the information of an entrant will not be shared with or sold to any other person or entity.

9. DISCLAIMER. THE FOUNDATION MAKES NO WARRANTY OF ANY NATURE WITH RESPECT TO THE RAFFLE OR ANY PRIZE, AND EXPRESSLY DISCLAIMS ALL SUCH WARRANTIES, INCLUDING WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE FOUNDATION EXPRESSLY DISCLAIMS ANY WARRANTY REGARDING THE PRIZES, INCLUDING THEIR USE, DESIGN, CONDITION, NON-INFRINGEMENT OF ANY PATENT OR OTHER INTELLECTUAL PROPERTY, QUALITY, CAPACITY, WORKMANSHIP, OR CONFORMITY TO ANY LAW, RULE, REGULATION, OR SPECIFICATION.

10. WAIVER / LIMITATIONS OF LIABILITY. By participating in the Raffle, entrants release, indemnify, and hold harmless the Foundation and its affiliates, directors, officers, employees, agents, and sponsors, including advertising and promotion agencies, from any and all liability with respect to the participation in the Raffle, the possession, use and distribution of the Prizes awarded, and all losses or injuries (including loss of earnings, profits or goodwill), damages, costs, expenses, rights, claims and actions or any kind arising in connection with the Raffle or the Prizes. If any provision of these Official Rules and Regulations or the application of any such provision to any person or circumstance shall be held invalid, illegal or unenforceable in any respect by a court of competent jurisdiction, such invalidity, illegality or unenforceability shall not affect any other provision hereof. The interpretation and application of these Official Rules and Regulations by the Foundation shall be final. These Official Rules and Regulations shall be binding upon and inure to the benefit of the heirs, executors, administrators, successors and permitted assigns of each entrant. The Raffle is being conducted in accordance with and is governed by the laws of the State of Florida. The offer to participate in the Raffle is void where prohibited by law and all federal, state, and local laws and regulations apply.
